## **Update that Affects your Bill**

As you may recall, last month as result of the winter storm, Brazos Electric Power Cooperative announced that it would be charging its member-cooperatives, including Tri-County Electric Co-op, an additional 2 cents per kilowatt-hour for purchased power. Tri-County Electric Co-op members saw this increase on their March billing statements labeled 'Brazos Winter Storm Adder', which increased the Power Cost Recovery Factor (PCRF) from 1.5 cents to 3.5 cents per kWh. **We are pleased to announce the adder has been removed by Brazos and <u>WILL NOT</u> be included on April bills.** 

## Update: Winter Storm, Grid Crisis & Brazos

Members will find an update on page 18 of the April *Texas Co-op Power* from Darryl Schriver, President/CEO, regarding the winter storm and grid crisis. Schriver continues to press for answers and accountability from Brazos Electric Power Cooperative, our generation and transmission cooperative and power supplier, regarding the winter storm, grid crisis and its bankruptcy.

▶ Your board of directors and management continue to be actively involved in discussions, meetings and hearings related to the winter storm and the Brazos bankruptcy filing. We are communicating with the bankruptcy court to ensure our members are protected through the process. 800804773

Even with proactive participation in the process, there are limitations as to what we can affect and control in relation to the problems of Brazos. ► The Texas legislature continues to ask questions of those at the Public Utility Commission (PUC) and the Electric Reliability Council of Texas (ERCOT) regarding the winter storm and grid crisis. The legislative committees are doing a great job getting to the bottom of the situation. Management is in contact with our legislators and promoting solutions to protect you, our member-owners.

### Wired in History:

The Tri-County Electric Co-op board approved a contract with Brazos River Transmission Electric Corp. for the purchase of electricity from a generating plant at Possum Kingdom Dam, cancelling the contract with Texas Electric Service Company as of May 2, 1942. World War II changed those plans, however, and it was not until July 12, 1948 that Tri-County began to get power from Brazos.
