## Brazos Bankruptcy and Summer Grid Conditions

We are three months into the Brazos bankruptcy and our commitment of transparency with you remains. As a member of Tri-County Electric Cooperative, you can rest assured that co-op leadership has your best interest at the forefront. Here's what you need to know this month:

- ▶ Brazos's bankruptcy is a fluid process that is far from over. Important hearing and filing dates are approaching and we continue to work with legal counsel and consultants to navigate this situation. This is a problem not of our making, but we are doing our best to represent the interests of the Tri-County Electric Co-op membership.
- ▶ The Electric Reliability Council of Texas (ERCOT) is predicting a hot summer, and higher temperatures typically include a higher demand for electricity. Co-op leadership continues to focus on system reliability and reducing exposure to market price volatility through these peak times. 800861301

### Members may be eligible for federal assistance to pay utility and rent bills.

The Texas Rent Relief (TRR) Program received \$1 billion in federal assistance with the recent Coronavirus Relief Bill. The funds help Texans with unpaid bills dating back to March 13, 2020.

Approximately \$100 million has been paid to Texans since applications opened in February 2021.

Eligibility includes households at or below 80% of the area's median income; one or more of the tenants qualify for unemployment benefits or can attest they experienced a loss of income or experienced financial hardship during the pandemic. 800697186

# Strawberry Ice Cream Pie

Strawberry Jell-O, 2 small boxes or 1 large box

¼ cup sugar

1 ¾ cup water

2 pints strawberry ice cream

8 oz. cool whip

3 graham cracker crusts

Dissolve Jell-O and sugar in water. Chill until thick syrup consistency. Beat until light and fluffy.

Add ice cream and beat at a low speed until ice cream is incorporated into the Jell-O mixture. Fold in cool whip.

Divide mixture among the three graham cracker crusts. Put in refrigerator for at least 2 hours to chill.
